#### **ORDER**

After full consideration thereof, The Board of Education of the County of Doddridge, being of the opinion that the maximum levies for current expenses authorized by Article 8, Chapter 11 of the Code of West Virginia 1931, as amended, will not provide sufficient funds for the payment of the general current expenses of schools in Doddridge County, including expenditures for the purposes hereinafter stated, during the fiscal years beginning July 1, 2024, July 1, 2025, July 1, 2026, July 1, 2027 and July 1, 2028 and have ascertained that the amounts hereinafter shown in excess of the amounts raised by regular levies will be needed by The Board of Education of the County of Doddridge during each of said five (5) fiscal years and that an election should be held to renew additional levies which were previously renewed by the voters of Doddridge County School District, February 23, 2019, it is hereby ordered and declared:

- (1) The purpose for which such additional funds are needed is the payment of the general current expenses of The Board of Education of the County of Doddridge, as follows:
  - a. Provide for capital improvement, construction, renovations and repair/maintain facilities necessary for safe and efficient operation including, improvements, renovations, and repairs that will enhance the physical safety and security of students and employees

#### APPROXIMATE ANNUAL AMOUNT OF: \$3,320,401

b. Provide funds for instructional materials including, but not limited to, supplies, textbooks, workbooks, fine arts, technology and library operations. To defray vocational, college & career readiness, and extended curriculum costs and continue supplements to county support organizations, including 4H.

c. Provide funds for supplements and transportation for extracurricular secondary school programs, including athletics and band. To continue to support the Extra-Curricular events pass for local citizens. To provide funds for professional development and continue funds for substitutes, inclusive of professional and school service personnel

#### APPROXIMATE ANNUAL AMOUNT OF: \$577,713

d. To continue to provide a safe, efficient, and adequate transportation system for the school children of Doddridge County through continued maintenance and improvements of transportation facilities and equipment.

- (10) In the event that the amount collected is less than the amounts noted for the above purposes for any one or more fiscal years, the Board of Education of the County of Doddridge County is hereby authorized and empowered to determine, in its discretion,

which one or more of the enumerated purposes set forth above shall be reduced for each such fiscal year, provided that the total of all such reductions shall not exceed the amount of such collection shortfall for such fiscal year.

- (11) In the event The Board of Education of the County of Doddridge shall obtain additional money by grant or otherwise from the State or Federal government, or from any agency of either, or from any other source, for the purposes aforesaid, such additional money may be used either in substitution for, or in addition to, the sums obtained from such additional levies as said The Board of Education of the County of Doddridge may from time to time determine.
- (12) That the question of such tax levies shall be submitted to a vote at an election to be held on November 8, 2022.
- (13) That should any item in the aforementioned purposes be declared unconstitutional or invalid due to judicial or legislative action, affected funds will be distributed among remaining unaffected items.
- (14) That notice calling such election shall be given by the publication of this Order once each week for two successive weeks.
- (15) That the ballot to be used at such election shall be in form as follows:
