The ACEPPRB makes recommendations to the WVBE regarding the approval of initial and continuing alternative certification programs for the education of teachers. Such programs make it possible for qualified individuals to earn a teacher certification that will help fill staff vacancies within areas of critical need and shortage. According to Policy 5901, the ACEPPRB is comprised of nine members who may serve up to two consecutive three-year terms: Two members represent higher education; three members (one who was alternatively prepared) represent public education, one at each programmatic level for elementary, middle and high school; two members represent county offices; one member is a principal appointed by the State Superintendent of Schools; and one member is from the West Virginia Commission for Professional Teaching Standards. The current vacancy is for one county office representative to be appointed by the WVBE. Heather Scarberry is the Manager of Professional Personnel for Cabell County Schools.

It is recommended that **Heather Scarberry be appointed to serve on the ACEPPRB.**

- 5. West Virginia University Partnership Agreement with Berkeley County Schools for Certified Teacher of Record (CTR) Positions – (Action)**

In December the West Virginia Educator Preparation Program Review Board (EPPRB) members agreed on a recommendation of approval to the WVBE of West Virginia University's addition of a CTR Program with Berkeley County Schools. WVBE Policy 5100 provides guidelines and procedures for the approval of new and continuing educator preparation programs of study leading to licensure in West Virginia and also for CTR Agreements with county school systems. Policy 5100 supports the intended collaborative process to improve educator preparation programs and potential educators by incorporating program guidelines based on research and best practices. Support of continuous improvement and clear and consistent guidelines for West Virginia educator preparation programs will produce more effective educators in schools, resulting in increased student learning in the classroom.

It is recommended that **West Virginia University's addition of a CTR - Berkeley County Schools be approved.**
