**Description:** Based on three previous West Virginia School Board Association trainings, regional meeting participants will participate in small group discussions of case studies regarding county board financial responsibilities. Case studies, preceded or followed by short introductory comments or lecture, focus on common areas relating to county board financial monitoring and oversight. Additionally, the West Virginia Board Association (WVSBA), working with various organizations and interests, has developed a series of policy templates and checklists or related documents that heighten monitoring and oversight. These documents will be presented at the conclusion of each session for county board perusal and comments. Once comments are received, the documents will be presented for final vetting to the West Virginia Board of Education's Office of School Finance, Office of Accountability and/or other WVDE Offices as the State Superintendent may designate. The seven regional meetings will occur from March 25, 2026, through April 28, 2026. Documents based on the regional trainings will be shared at the WVSBA June 2026 Orientation for full Association implementation by July 31, 2026. Presenters include Kimberly S. Croyle and Leigh Anne Wilson (Bowles Rice LLP) and designated County Board Treasurers and/or School Business Officials, representing county boards within each of the regional meeting regions as recommended by the West Virginia Association of School Business Officials, will serve as meeting faculty resource persons. Each training will provide participants 2.0 hours training.
