Rebuilding Nicholas County Schools Mediation Process

Compilation of Public Input April 26, 2018

This document compiles all public input received by the <u>Consensus Building Institute (CBI)</u> on behalf of the mediation team between March 29, 2018 and April 24, 2018. Public input was received via email at <u>ncschoolsmediation@cbi.org</u> and in the form of public comment cards, index cards, and sticky notes placed on posters at a public workshop held on April 12, 2018. All forms of public input are treated equally and all public input is provided to the mediation team (comprised of representatives of the West Virginia Board of Education and the Nicholas County Board of Education) for their review.

Comments are reproduced here as they were received, with slight edits or redactions made in some cases to protect the identity of the commenter or to remove references to specific individuals named in comments. In addition, in some cases individuals providing input via email provided comment in the form of attachments and those have been appended to this document.

3/29/18	Media Communications: Participants agree not to speak independently to the media about the ongoing deliberations, but rather to work through neutral and jointly-acceptable statements. No participant (mediation team of 3 ncboe) will attribute statements to others involved, seek to present or represent the views or position of other members, nor attempt to speak on behalf of the deliberations as a whole in or to the media. "Media" for these purposes includes the press, television, radio, websites, social media, blogs, and any public information distribution mechanism. Participants will abide by these ground rules in "all communications during in and out of meetings. Apparently you have a Leaker among you. the rumor on the street is that you already have a decision and Richwood is not getting their High School back, but a 1-8 school. We have attended all but 2 of your board meetings and have heard nothing about this. Can you explain why this information is floating around?
3/30/18	Does this seem equitable? Months ago rumors soared that would continue to build her palace in Summersville and would throw up a shack in Richwood so everyone would transfer to Summersville. This looks like that plan. Why is the vocational school moving to Summersville? If there are going to be two high schools in Nicholas County, why destroy a perfectly good Career Center? If they want the Summersville schools to be with the Career Center, why not build their schools in Craigsville and save LOTS of money. Why destroy Nicholas County High School that is supposed to be refitted for the elementary school; if it is fit for elementary students, then it is fit for high school students. Are we trying to save Summersville and the Business Park or trying to do what is best for ALL the students in Nicholas County. This plan is not good for the elementary students in Nicholas west. It is not the best plan for any student in Nicholas east. If this plan comes to fruition, no bond or levy will every pass in Nicholas County again. That will devastate the education of students attending Summersville Elementary. Even if her plan to retrofit NCHS for elementary students evolves, those children will remain in an unfit school for another 10 years before the retrofitted NCHS is ready. Are these the only plans you have?
3/31/18	The plan not to make vocational classes available to Nicholas east students without them changing schools and traveling an extra 25 miles to the "geographical center of Nicholas County" appears to be in opposition of the The Recht Decision of May, 1982. in the Pauley, et al v. Kelly, et al, lawsuit.
3/31/18	Why did you choose Nicholas County High School for the public meeting? I believe it was discussed in the meeting agreeing on the mediation process that the public meetings would be held in a neutral environment. Pretty sure the high school is not a neutral environment.
3/31/18	We are ready to go. Let's get this show on the road. Students don't deserve to be punished, walking from pod to pod in the rain snow and mud.

	To whom it may concern: I read the proposal from Mediation the County Board Posted. I have a few questions. Why does Richwood need a new grade school? Why does NCHS get all new athletic fields and RHS does not? RHS fields were ALL flooded. Will RHS get a Career Center also? What will happen to the existing Career Center in Craigsville? Can RHS still use that as our Career Center? If only NCHS gets a Career Center then how does RHS take Career Classes? Will they be bussed to Summersville? Or will they have to be a student at NCHS to take Career Center Classes? If we get a new grade school in Richwood then could we use the old CRE for a Career Center? Just seems fair for both schools to have a chance to take Career classes at their own schools. Thank you.
3/31/18	I do not feel this plan is in the best interest of every student in Nicholas County. Both schools should have access to a vocational center. Richwood lost two schools, which by the way could have been repaired. I find this proposal a huge waste of taxpayers money. It is said that we should trust our local board, that is hard to do when they have lied to us since day 1. As a teacher in Richwood, I know this email will only make the target on my back get larger. I think equality in education is a must and this plan does not present equality. Sure if the students want to spend more time traveling and being pulled from their community it is, but what about the student who feels safe in the smaller community school? How is it fair to deny them of a vocational course? We stress family time and students who have to travel great distances are deprived of the valuable family time. These students who travel for more than an hour one way do not get to participate in sports or other extra curricular activities. This plan deprives all students of an equal education. I pray that there will be changes made to this proposal to ensure all Nicholas county students can thrive in their given communities.

Additionally, I'll point out that the recent statement issued stated that the NCBOE was financially sound however this organization continues to undermine that by stating the opposite and insulting a significant portion of the county with the amount they pay in taxes. I hope that you will follow up on these issues.
4/3/18	I recently read your suggested proposed plan which would build a small K-12 school in Richwood and a comprehensive middle, high and vo tech school at Glade Creek. I am very much in favor of this plan.
4/3/18	Hello, I would like to be able to show my support for the proposed mediation plan but I won't be able to attend on April 12th.
4/3/18	I just want all of the students in Nicholas County to have a permanent place to go to school.
4/3/18	To whom it may concern: I am sorry that I am unable to attend the public meeting scheduled for April 12 as I will be out of town. I want to let you know of my support for the mediation plan submitted. I have spoken at 2 Board of Education meetings in regard to the consolidation process. At the second meeting, I concentrated on the need for a centralized votech in the county and you can view my individual comments on the SCTV video. As a public defender here in Summersville for over thirty (30) years, I can assure you that my clients do not usually attend post-secondary schools, and it is my firm belief that a centralized votech would greatly assist my clients in obtaining job skills and subsequent employment. Many of my clients over the years have indicated to me that they do not attend the votech because it required additional bussing. Some students could not participate in AP classes and still attend votech because of scheduling issues because of the 2 locations. I also noted in my speech that very few from Richwood attended vo tech programs because they could not participate in both band and votech and the band was the preferred choice of the vast majority of the Richwood High School student population. After my speech, the I am Richwood page made numerous derogatory comments about my speech on the expansion of the votech program. made particular fun of some of the job skills that could be provided, which included dog grooming. He obviously is not aware of the fact that some people, including many of my clients, could actually learn that vocation and provide a good living for their family instead of collecting a monthly check from the State of West Virginia. I believe the mediation team came up with a great compromise that gives Richwood the small community school they desire, but also gives the majority of students in Nicholas County a chance for an excellent comprehensive educational component which will be available to all students in the county regardless of where they live. Summersville City is and has been providing financial assistance to Richwood Schools for a while now. Before the RHS was torn down, Summersville City was asked to pay for the blinds in the school. The economic situation is dismal in Richwood. I would think a readily accessible hospital and law enforcement would be of great interests to all with the threats of increased safety of our school children. Please consider this and do what is in best interest of all involved. Let's get these kids schools, Plan A is acceptable
4/3/18	I am a parent of a Richwood High School student and I also support your plan to build a comprehensive high school and votec in Summersville and pre k-12 in Richwood. My son deserves the best education possible and I believe the plan for the Summersville School will provide just that. I cannot attend the meeting, but I do thank you for all the work that you have put in to resolving this problem.
4/4/18	I fully support school consolidation in Nicholas County. While the present proposal is not the most cost effective for taxpayers. It does represent a settlement between the different groups. Please note for the record all the many fiscal issues with the Richwood city's varied problems and potential insolvency. Richwood corporation used to be the largest district by population and property taxes that support schools and local government. It is now the very smallest in the county by both population and tax base. In turn Summersville Corporation is now the largest in the county. Good effective schools and government was the basis for sound decisions regarding all children in Nicholas County. Very disappointing that politics got in the way!
4/4/18	This antagonistic language appears nowhere in the mediation post by you: since is the "A" in the ABC of this post and both he and are the NCBOE, they are responsible for this announcement. In addition, they add the WVBOE to this, implying your approval. Did you authorize and participate in this release? If not, are they not in violation of the media communications protocol which states; "Participants are not to speak independently to the media about ongoing deliberations No participant will attribute statements of others involved, seek to present or represent the views or position of their members, nor attempt to speak on behalf of the deliberations as a whole in or to the media." Why hold the FEMA hearings in Summersville instead of Richwood, the community most affected by the flooding? Could there not be two meetings, one in each town? What difference does it make that the Nicholas County Career and Technical Center be in the "geographical" center of the county? Only the two high schools participate in the program and the current school is exactly centered to both. The building was not touched by flooding and this faculty has expressed a desire to remain there at the previous hearings. Why does FEMA even include schools which did not sustain any damage in the deliberations? Do they plan to waste money on a new athletic field within sight of an already premier complex while Richwood students may travel up to three miles to their field? Are they really going to allow the purchase of up to 80 acres at a cost of \$4 million?

However, you obviously recognize that the pro community schools people need to be involved or nothing will ever be solved. It appears that a two hour workshop will not be sufficient for all concerned individuals to express their concerns. Will there be other workshops? Will individuals be able to express their desires if they do not have an opportunity to attend the workshop? There are so many negotiation points that need to be evaluated that you have a long road ahead of you.

I'm also concerned with the proposal of building a K-12 in Richwood when there is not a need for a new elementary school. As a taxpayer I believe that is a wasteful plan. Our students deserve an equal opportunity to participate in sports and extracurricular activities. We currently have one gym that is shared between both middle and high schools. It is difficult for our athletes to get adequate practice because there is not an additional gym for them to utilize. I'm a taxpayer, I'm a parent and it truly breaks my heart when my girls ask me why their school isn't worth saving. It's hurtful when there is still talk of consolidation as if our kids, and the additional 52 miles from Richwood to Summersville and back is irrelevant. I've driven some long commutes in my career and it's difficult and a waste of time. Students getting up earlier and getting home later is not conducive to a good attitude towards school and learning. I'm not wealthy, politically influential or anything special but I love my children and my community and I believe we deserve to be treated fairly and with considerably more respect.

4/9/18	I have several concerns about the proposed plan for rebuilding Nicholas county schools. Richwood has an elementary school that does not need replaced at this time. Richwood
	does, however, need grades 6-12. Both the middle school and the high school were damaged by the flood and located in the floodway. A new 6-12 school with a vocational school would serve the students much better than a K-12 school. If the only CTE is in Summersville, that would restrict many options for our students. If they want a vo tech class, then they would have to travel to Summersville to school. That is unfair to these students. According to the 1982 Recht decision, this is also not legal. Over the years, there have been many laws passed to prevent this exact discrimination to students. The Individual Disabilities Act requires equal opportunity for all students. In the city of Richwood, we have two sawmills. Craigsville has Columbia. There are many local businesses that will benefit from students being educated in the Career and
	Technical Center. If you make our students be bused all the way to Summersville for school, participation in the CTE for our students will decrease. With the current set up, 17% of RHS students participate in the votech (14% of NCHS students participate). Please rebuild adequate facilities in Richwood for our students.
4/11/18	I will be unable to attend the mediation meeting on April 12th but I wanted to let you know that I am in favor of the proposed plan. Thank you.
4/11/18	*My main concern is who is representing what Richwood's schools need??? We know it's not the NCBOE because they all voted to close Richwood's schools and consolidate. Yes in the proposal Richwood is getting a school BUT it's like Summersville would be getting a 5 STAR SCHOOL with all the AMENITIES (6-12) school -VOTECH- art facilities-educational opportunities and a FULL SUITE of athletic facilities (mind you not ONE of their fields was under water and their HIGH SCHOOL wasn't was flooded). 4/11/18	As I read the information in the mediation report one sentence caught my eye in particular"Communities support their schools and trust their school boards." From the beginning of this fight we learned to not trust the Nicholas County Board of Education because they would not give us a voice to express our thoughts. We were the ones to have two schools flooded, but they made up their minds to not listen to us. Until the WV State School Board gave us a voice, we had none. We also do not have a voice on the mediation committee. We are hoping that has been our voice; we have no other. I believe you will find out at the meeting that my thoughts may be similar to a lot of other Richwooders. 1. We need a new middle school and high school in Richwood.
	2. We do not need a grade school. We have Cherry River and it appears to be in good shape. 3. We do need a Career-Tech Center in Richwood. It is not fair to the students to say that if they want to go this route they have to go to Nicholas County High School. This penalizes them when they have done nothing wrong. We should have our own Career-Tech Center in Richwood or the one should be left alone in Craigsville and expanded if desired.

4/11/18	After hearing about the "Meet the Candidates Night in Summersville last night I am sure that Richwood is not being represented by your mediators when a NCBOE member publically states that looking at the numbers the mediators are on NCBOE's side. Combining SMS/SES would provide a much needed new SES and give SMS back a permanent home
4/12/18	What does "community school" mean? Students only living in town at Richmond or very near by?
4/12/18	Learning more about tech school most important to me. Same class at both school.
4/12/18	The workshop was very helpful. We were not sure if the proposal was for a k-12 in Richwood or a 6-12? Richwood does not need a new elementary school. You need to ditch the "community" versus "comprehensive" terms. What are the differences between the two? I would like to see a side-by-side comparison of the programs/options both schools will have. Do both schools get updated sports facilities? If students are allowed to pick their school, you will create something similar to private wealthy schools that will recruit desired athletes. Enrollment from year to year will fluctuate tremendously. Transportation costs will skyrocket. Boundaries need to be set and followed. If parents do not like the school their children are required to attend, then move to the desired area. Sports programs will suffer along with educational opportunities. CTE is also a big problem. Richwood children should have the same opportunities as NCHS. Keep the VOTECH at Craigsville and update it. The problem with low enrollment in Votech, I feel, is the lack of choices children have. They need computer classes, drafting and a larger variety to choose from. SES needs a new school. They do not need a retro-fitted high school. As I sit here in NCHS, I do not see where it is damaged or falling apart. Why is it proposed to build a NCHS? They were not flooded, their children are not displaced. Children need to be a part of extracurricular activities, otherwise, they will have nothing to do but get into trouble. If the students have to enroll in a career center in Summersville, they won't be able to participate in extracurricular activities. The tech center needs to stay at Craigsville or each school should have one.
4/12/18	Please give both schools NCHS and RHS equal facilities. RHS needs a career center also or leave at Craigsville and share between schools and ad on. Please be fair, if the career center is at NCHS only, it may draw more students to NCHS and leave RHS to dwindle.

4/12/18	Looking around the NC high school cafeteria, auditorium, etc. It seems so nice. Then looking/driving through Richwood - why is this even a discussion? The students from Richwood need some schools! As promised!
4/12/18	It is our conclusion that the plan that has been proposed is appropriate to meet the needs of all students in Nicholas County. Please proceed as planned.
4/12/18	I am for the proposal.
4/12/18	We just realized we sent the incorrect version of the document earlier. This is the Corrected Final Version.
4/12/18	I agree with the current plan. Unable to attend meeting tonight.
4/12/18	I am unable to attend the mediation meeting tonight but I feel the plan set forth would work for all students in the county. A k-12 would service the Richwood community and middle/high schools with vocational center would service the rest of the county.
4/12/18	I have seen the proposal for the new schools. I emphatically agree that there needs to be a secondary school in Richwood. I noticed that the proposal mentioned K-12. We have a good grade school in Richwood, and I hope that you are not planning to destroy that in this process. Richwood needs 6-12 with a career and technical center (unless you plan to leave the vocational school in Craigsville for the use by all of Nicholas county and the students in Webster county). Richwood needs the gym and auditorium that were mentioned. They also need a band room. I believe Richwood has the largest single A band in the Nation (or very close to it if not the largest). Another concern I had was the mention of a CTE in Summersville. Are you thinking everyone that wants votech should go to Summersville to school? had previously threatened the staff saying that she would send all of the students in Richwood to Summersville to graduate as a Grizzly. I am concerned that this proposal will require any student on the eastern end of the county to go to NCHS in order to take vocational classes. This would require up to 100 minutes of travel time each way. Many students don't want to leave their friends, sports, and band to become a NCHS student. It doesn't seem like a valid plan to make them choose between a vocational class and everything else. Is this proposal legal in light of the Recht Decision, the Civil Rights Act of 1965, Title IX, and the 1989 Individuals with Disabilities Education Act? It appears that progress has been made in rebuilding our schools, but that there is still much that needs planned. I would hope that since 100% of the secondary students in Richwood are in unconnected pods, that the school building process will begin there. That school can be started while the land preparation begins in Summersville.

4/12/18	I was originally scheduled to attend the meeting this evening in Summersville but my involvement with youth sports in the area will keep me from being able to attend however my wife will be there. I am a father of 3 kids who attend schools in Nicholas County and we live in the Craigsville area which is currently the largest populated area that feeds the Richwood schools. That being said our children attend schools in Summersville and not Richwood due to certain academic and sports related activities they offer that are not offered in Richwood. My daughter recently signed a letter of intent to play collegiate soccer for Glenville State College in the fall. If she would have been forced to attend Richwood area schools this would not have been a possibility as they do not have a soccer program. I believe the proposal put forth by the mediation team was adequate and was accurate to what I mentioned myself in the mediation meetings held in Summersville. 4/12/18	I am a student at Richwood Middle School. I will be attending Richwood High School next year. It has been almost 2 years since the flood. The new schools have not even been started yet. I have to go outside in between every class on slick, wet walkways. I had hoped to graduate from a solid, real high school. I am concerned with the first proposal from the mediation team. It says the plan is to build a small K-12 school in Richwood. We already have a good elementary school. The only way I could attend the vocational school would be to travel to Summersville. I enjoy participating in sports in Richwood. I know if I have to transfer to NCHS, I will not be able to participate in sports. It would take me over an hour each way to travel to a school in the Glade Creek Industrial park. Since the vocational school in Craigsville did not flood, why would you build a new one? Can all students still use the CTE in Craigsville? If so,you could rebuild SMS, RMS and RHS. Those are the 3 schools that flooded. Richwood lost 2 gymnasiums, 2 cafeterias, an auditorium and the schools. I would hope as you finalize plans for rebuilding the school in Richwood that you consider the needs for all of our students.

Nothing should be done that shifts in only one direction.
The 2 schools must be separate but equal. Vo Tech - Career center needs to stay in Craigsville and expand. The FEMA money was to rebuild the flooded schools, not a huge school in Glade Creek. Students and parents should not have to schools a school. Each school should offer excellent classes with great teachers.
I appreciate the effort everyone has put forth coming to compromise. It was mentioned by Dr. Paine during the presentation how important the CTE is to the community - that it imperative for BOTH high schools, whether it is left and revamped in Craigsville or configured into both schools to provide necessary and additional classes.
Sustainability is of the utmost importance. The taxpayers and tax bases of each community must be considered. This is not an equality issue it is a sustainability issue. I love the existing proposal. I love the fact that parents/students get a choice which school to attend. Consider rotation of staff and students. SMS/NCHS parents/taxpayers fund more for the schools in terms of taxes.
I am the proud parent of beautiful children. While I appreciate Richwood's position, I definitely don't agree on everything that is happening. First of all, since consolidation seems to be off the table, I can't see how or why anyone would consider giving them more than bare necessities. They have absolutely no infrastructure and have no feasible growth plan to suggest that they ever will. It doesn't make sense to build two career and tech centers. Second, I also believe that this debacle has gone on long enough. We need to move forward with building and get our county back to normal. This is only hurting our children. Why would we cater to the minority? Democracy is founded on the most votes. How can Richwood have less people and less of a vote but still get all they want? Third, I would like to apologize for not showing at the consolidation meetings. I work out of town and can't just leave in the middle of the week. I care very much about my children getting a better education than I did. The only rational thing to do is build where the resources for the best education are. If I had a choice I would love to see us take full advantage of this opportunity to build one school. Let's really bring this county together in a way that we can all be proud of. A new consolidated school could do that if we could come together like real West Virginians and not Richwood vs Summersville. It is time to move on and get over their High School attitude. Grow up.
The proposed school at Glade creek with a career technical center on campus would provide Nicholas County Students an opportunity to participate in STEM programs to a much greater degree than they are currently able. It would also provide students who may be undecided, a chance to explore other possible career choices without having to lose a large portion of their day to travel. A college-bound student with an interest in science and technology has an academic schedule that would prevent them from attending an off-campus facility due to the loss of a period or more for travel. According to the demographics of Nicholas County, the majority of the population with school age children resides outside of Richwood and Fenwick. Educational decisions must never be used as a way to save a community, they should always be about what is best for the entire community of Nicholas County. The only arguments against the current proposed plan are based upon political interests and impact on property value. To an outsider, the obvious solution is to consider students first and what is in their best interest, not what is in the best interest of a few individuals who have vested interests not related to education. Any other decision clearly favors these few individuals who are property owners in and around Richwood, not the overall population of Nicholas County. As a School Teacher who has taught in both communities, I believe that the proposed plan provides Richwood with the school they seek, and the majority of students in Nicholas County an opportunity to pursue an education program that is diverse and challenging, while preparing students for future careers in Science and Technology. Access to these programs is currently underrepresented and inaccessible to the majority of students in Nicholas County.
I am a lifelong resident of Nicholas county. I was born here, I went to school here, I am currently raising my children her. I graduated from RHS in 1998. My oldest daughter will graduate from RHS , my second oldest will graduate from there and hopefully my twins will have the chance to graduate from there in the future. I have many concerns about this proposed plan for the schools in this county. The first is that it completely unfair to build a huge school in Summersville and a crappy school in Richwood. How could anyone look at the children in this county and say "You have this crappy school and they will have this big fancy school."? I understand the children will have the choice of where to attend school. The vocational school will be moved to Summersville and if I want my child to attend Vo Tech, I will be forced to send him to a school I do not want him to attend. How is that fair to me, or him for that matter? NCHS and the vocational school were not flooded and do not need rebuilt. They can be renovated for much cheaper. It is not fair for the children who lost their schools for Summersville to benefit from such a devastating flood that did not affect those schools. In my opinion, a middle/high school OF EQUAL VALUE, CONTAINING THE EXACT SAME THINGS should be built on both sides of the county. The vocational school should be renovated. School boundaries should be enforced.

My mediator did an amazing job, but those of us from Summersville and other surrounding areas still did not feel free to speak without being verbally assaulted or overturned. I would like to say that I fully trust and stand behind our local Board of Education members and superintendent, they have done an amazing job. I also feel that our State Board of Education, through mediation and cooperation with our local board and superintendent, have presented a plan that is a very fair compromise and fiscally responsible for ALL of Nicholas County. Vocational services must be offered to all of our students, but the vocational school currently sits beside Richwood High School and their number of students is still extremely low. By offering sound vocational courses at NCHS campus, we will be able to provide more curricular opportunities and diversity of curriculum for all students in Nicholas county. This would be utilized by not only Richwood, and Summersville students, but by Dixie, Mt. Nebo, Mt. Look Out, and Birch River students as well. The proposed location at Glade Creek would provide a centrally located county Vocational Center for everyone in Nicholas County. As an older veteran teacher of 20 years who has taught in 3 different counties. I have been through a consolidation in Greenbrier County years ago when 10 Jr. Highs were consolidated into 2. While I was saddened by it because my old alma mater became an elementary school only. I was one of the teachers in the new school. It was a tremendous improvement in every way because of quality leadership, newer, up to date facilities and equipment, and the fresh start in everything from academics, teacher groupings, athletics. and fresh new goals. Consequently, I have approached this county's consolidation with hope, but because of the incredible backlash of hate and small thinking, I as well as most of my colleagues from this end of the county, have become skeptical and frustrated by what should be an incredible opportunity for the whole county. Students come here unable to type or navigate basic computer programs because of numbers? And, we have no business or accounting classes. We have no library, And those are just a few basics. I would love to see enough numbers to justify something more than core classes. Shoot, I would love to just have enough computers or text books to teach the students we have, but that's another story. Having the vocational campus in walking distance, instead of bussing distance is also a huge asset. As a core teacher, I strongly believe that vocational classes should be utilized by ALL students, not just those who are not academic stars. And yet, because of our current set up, none of our academic students can fit vocational classes into their schedules. Add to that the bussing time to and from the vocational school, and even fewer students are able to even think about trying a "skills" class, which I personally every student should be required to have in some form. As you can see, I'm all for providing a newer, up to date facility that has a vocational campus in conjunction with an academic campus. I married a man who took votech classes in high school, and while he has earned 2 master degrees and a doctorate, he still uses his vocational skills every time he wants to "try" something, which has included building onto and redoing our homes over the years. As a coach, I also am excited that facilities could be created to include all athletics. including soccer, which gets pushed to left over fields for practices, or cross country, which currently has to leave campus to practice at the lake or some place that is safe from traffic for practices and meets. The thoughts of a possibility of a pool really excites me because not only could students learn to swim or get life savings classes, but also could be utilized by sports team for recovery practices as well as developing a swim team. The benefits of your proposal far outweigh the hate and backlash that we have grown tired of, so I just wanted to speak on behalf of your efforts as I'm sure you will undoubtedly hear arguments against it. Some of us felt blindsided as we do not understand how they obtained the information in time to type and distribute notes. It was obvious they were better prepared than those of us who were seeking additional information, but who received LITTLE information at the discussion because pro Richwood proponents were loaded for bear (and I do mean grizzly) and dominated most discussions. The only modification I recommend is providing transportation for RHS students to come to the CTE. I suggest the RHS students ride directly to the CTE in the AM and return to RHS around noon. The students from Nettie-Leviasy and Craigsville area would come directly to the CTE and not RHS but go to RHS after their classes at the CTE. I am writing in negard to the recently released hicholas County schools mediation proposal. I was unable to attend the public workshop on 41/21/8 due to a Boy Socut obligation. We moved back to Nicholas County, my childhood home, when my oldest son was 4 years old, after Iving in the area, where I attended college, for about 10 years. My oldest child is a student in the grade at Summersville Middle School, also known as "Pod Cilk," My youngest son attends grade at Birch River Elementary. We reside about 15 miles from Summersville Middle School and Nicholas County High School. Our home is located approximately 24 miles from the Nicholas County Career and Technical Center. My child's bus ride to and from SMS averages 45 minutes each way. I was, and still am, a proportion for consolidation of all the secondary schools in Nicholas County. We live within walking distance of our local grade school, Birch River Elementary. We reside about 15 miles from Summersville Middle School and Nicholas County High School. Our home is located approximately 24 miles from the Nicholas County Career and Technical Center. My child's bus ride to and from SMS averages 45 minutes each way. I was, and still am, a proponent for consolidation of all the secondary schools in Nicholas County. However, I fully support the elements contained in the latest mediation proposal, as I recognize some give and take is required to reach a solution. The Glade Creek area is the most central available location for a comprehensive school complex. A central location in the county is necessary to entice children to want to attend a Career and Technical Center. As it stands, my middle schooler will likely not attend the CTE school in Craigsville when he reaches high school due to the lengthy travel time involved interfering with his participation in the band program. When I was a student at NCHS (1994-1997), the additional travel time and bus ride was the primary reason why many students did not attend what was then called the Vo-Tech. You could not be in band or choir, or take AP classes, if you went to Vo-Tech. You missed periods of instruction while you were being bussed to and fro. We need to extend the same opportunity for career and technical education to all of the children in the county. With this plant, they simply arrive at school for the day without having to get back on a bus for a 30 minute ride after riding for up to an hour in the morning, then again after school. I under

4/16/18	I would like to take this opportunity to comment on the mediation team's proposal. The proposal does not meet the needs of all the students of Nicholas County. Putting the Career Center in Summersville prevents the students from Richwood from having easy access to it. Richwood lost a 1200 student capacity high school and a 750 student capacity middle school. Summersville lost a 1200 student capacity middle school. There is enough FEMA money available to replace the schools that were lost. The people of Richwood are willing to accept a comprehensive consolidated high school/middle school in Richwood. We don't need a new elementary school. Nicholas county does not need a new vocational school. The facility at Craigsville is more than sufficient. It is presently serving three schools, and is centrally located between those schools. There is ample land available in in Nicholas County that can be purchased for a lot less than 50,000 dollars an acre. The reason that the NCBOE wants to put the Career Center in Summersville is because they can't get the Glade Creek property otherwise. If the Summersville school includes a career center, then the Richwood school should also. However, if the career center is moved out of Craigsville, it won't be easily accessible for Webster County High School. All student are important. I feel that it is a waste of money to build a new elementary school for Richwood and a new career center when the facilities that we have here are sufficient. Summersville needs a new elementary school. FEMA funds won't pay for a new elementary school in Summersville and renovate the present high school to accommodate the needs of the elementary students. I would like to add this thought: The NCBOE members and superintendent are temporary entities, especially with the current division in the county and an election for three new board members looming. On the other hand, the schools will be here for years to come, if not permanently.

Can We Grow More Opportunities for Students?

How Many Acres?

Some people want a new high school on a few acres in Richwood, while school superintendent Donna Burge-Tetrick wants 50 acres for a consolidated high school. Is there a better idea?

I knew students from a high school of 200 students that was located on a 300-acre farm. Interested students provided most of the labor on the farm. They supplied all of the beef and eggs used by the school. They fed and milked about 30 dairy cows. After the milk was pasteurized, it was used at the school.

Nicholas County has two high schools, plus Vo-tech at a third location. This three-way split often results in there being too few students at any one location for teaching natural science classes and training for in demand trades. Without dedicated instructors, there often isn't anyone to apply for and administer the grant money available for natural sciences. Some of the grants are for only \$15,000 to \$25,000; but, if you get enough of these grants, it adds up to serious money.

If Nicholas County settles on too few acres for a new high school, I fear we will end up with buildings whose windows face mostly east and west, resulting in lots of glare in the classrooms. In Glade Creek Industrial Park there are up to 175 acres available. If we, the people of Nicholas County, what would we do with that 175 acres?

- 1.) Woodland studies, for example: Take the wooded part and set up outdoor classrooms for economic and health reasons. Do crop tree release experiments. Create habitat attractive for newts and salamanders. Ticks that feed on newts take in blood and the newt's antibodies. Newt antibodies kill the spirochete that causes Lyme disease. Some birds help prevent Lyme disease by eating ticks that have the spirochete. So allow students to raise and release bobwhite quail.
- 2.) Grassland studies, for example: Plant pearl millet, where before a lawn had been planned, for setback or buffer space. Let students count and identify insects that live there. Compare that diversity to what is reported for a corn field. Let students observe and identify the birds and mammals that feed and/or nest there. Only mow the pearl millet when it will be used to make round bale silage (haylage). Let students see how it compares with the nutritional value of corn silage and other winter foods for farm animals.
- 3.) Food as medicine studies, for example: Let students engage in the growing of plants and mushrooms that can prevent and treat diabetes.
- 4.) Foster creativity by being innovative, pretty, and practical. Instead of boring lawn, let's plant edible flowers and other edible landscaping. Let the place have some life and imagination, instead of landscaping like the outside of a prison or military boot camp.
- 5.) Begin agriculture programs that train students for other trades. Some equipment companies will loan backhoes, farm tractors, forklifts, front end loaders, or small excavators to schools with strong resource programs. Equipment is brought in as a one-month demo, which the company writes off as a cost of promoting its product line. This equipment allows students to learn about electricity, hydraulics and so on.

Two examples follow. A variety of equipment can spread wood chips for mulching and growing edible mushrooms. Each experience would be real for students, because it is productive work and they don't have to be so on edge if they drop some woods chips or a mushroom log. These experiences could help students be more skilled and more careful when they drive an automobile.

To put these and other ideas into practice would take time. Time will be needed to apply for grant money from various institutional and government sources. As we build on successes, the process will get easier and we will be considered eligible by the bigger donors.

With all that could be accomplished, why are some people working to limit the possibilities by insisting on land parcels that are far smaller than the 175 acres in Glade Creek Industrial Park

If passive solar energy is made part of a new school building, it can be used to save money and enable students to learn the dynamics of the system. Plus, exposure to more natural light can lead to improved test scores for students. (Most consumers buy light bulbs based on the amount of light produced, rather than the quality. Farmers learn the differences or suffer losses. For example, using the wrong kind of light can cause hens to stop laying eggs, especially in winter months. Effects on other animals and humans are more complicated.) Do you want timd to be used or ignored? Popele think of harnessing the wind by using a windmill, where blades go around in a circle. Wind energy can be harvested by tall cylinders that spin. Think of a tall flagpole that serves as t

Last year when I attended the final WVBOE meeting I was so relieved to hear that we had a chance at getting our schools back in Richwood. It was my understanding that the NCBOE was going to work with mediators and representatives from both Richwood and Summersville. Instead the WVBOE met with the NCBOE and came up with a plan that was a mirror of the plan proposed by the NCBOE. the one that was considered unfair by the WVBOE to begin with. Compromise components for Career and Technical Education (CTE)

In the discussion at table 17 on April 12, 2018 the Richwood faction complained about not having a CTE at Richwood. This complaint persisted even when it was offered that for each current CTE class there are only two students from Richwood. There are a number of ways to have components of CTE without having a full CTE or even a full time CTE instructor. A few examples follow below:

- 1.) Hydroponics could be part of a biology class and give students valuable experience. With \$40,000 of equipment could easily supply all of the salad greens for the K-12 being considered for Richwood. The room for hydroponics will be about the size of one half of a classroom. It takes very little time. In commercial operations, one worker is needed to produce a million heads of lettuce.
- 2.) Make composting part of the education experience. Use compostable lunch trays. See page 10 of April 15, 2018 Parade magazine and urbanshoolfoodalliance.org Ban plastic straws. See earthday.org and lonelywhale.org If students are involved in these projects, they are also likely to be less wasteful in their use of food and other resources.
- 3.) Edible landscaping would help students learn what is edible and why. If students pick edible flowers as part of making their salad for a meal or snack, they will gain a very different approach and attitude to eating healthy. An easy example is Calendula, because it has a long bloom period and often blooms nearly until the first frost.
- 4.) Utilize green space to educate students and feed students. Green space refers to land that FEMA determines is not suitable for building. A number of proprosed sites in Richwood for a new school will be rich in green space, because of wetland or flood plain issues.

Round bale silage would allow students to learn about the fermentation process. Can a farmer be found that will volunteer to plant pearlmillet and harvest it as round bale silage on land not suitable for building? It is also a crop to provide insects, seeds and cover for bobwhite quail. A school with bobwhite calling would make for a very memorable experience. The male call is very peaceful.

Sunroot (also called sunchoke and Jerusalem artichoke) is in some ways the best food for preventing and treating diabetes. (Its carbohydrates are in the form of inulin instead of starch.) It prefers moist soil and can tolerate flooding. Some varieties of sunroot are very knobby making them hard to clean. A few varieties of sunroot produce tubers that more closely resemble the shape of sweet potatoes. Alternating sliced sweet potatoes with sliced sunroot and then roasting can be a quick way to provide a tasty and nutritious meal.

Arrowhead potato is a delicacy when roasted. Can be prepared like a hot cereal. It may have many of the health benefits of sunroot. It can thrive with proper design of water and sediment control structures as well as rain gardens.

Schools Configurations for Nicholas County

Overview:

This document is a practical assessment of the mediation team's proposed configuration of Nicholas County Schools. It is followed by four suggestions for more reasonable and equitable plans.

- The proposed configurations put forth by NCBOE and the mediation team put at risk a pre-flood county wide design that has a proven record of achievements and community support. For many years the pre-flood percentage of student population loss was greater for the NCHS/SMS feeder area. RHS/RMS student population had begun to stabilize before the flood. After the flood, the school district borders that determined feeder areas were dissolved and allowed open enrollment throughout the county. This caused an increase in transportation costs, further burdening the county economically.

Regardless of open enrollment or firm enrollment borders equal opportunities and facilities should be made available to children in both of these schools. Otherwise, the configuration would create unequal academic and extracurricular opportunities and deny all students in Nicholas County a thorough and efficient education.

- The proposed configurations put forth by NCBOE and the mediation team go against sound educational research.

A preponderance of research over the last 25 years has proven that smaller community-based schools are more effective and efficient. These studies have been provided to NCBOE and to the State Board, but practically no research was presented at any of the closure hearings nor at the state and local board meetings by the NCBOE to indicate that larger or consolidated schools save money, improve student performance or benefit their local communities.

The comprehensive research over two decades shows a cumulative negative effect on students and taxpayers in educational and economic aspects. The negative impact is greatest in low socioeconomic designated areas, which are numerous throughout Nicholas County.

- The proposed configurations put forth by NCBOE and the mediation team close a highly utilized and effective career center.

For the 2018/2019 school year, 34% of the RHS student body will utilize the Career Technical Education (CTE) center in Craigsville compared to 29% of the NCHS student body. Most programs are at or over enrollment capacity.

Nicholas County Career & Technical Center (NCCTC) is centrally located between Richwood, Summersville and Webster County High School, and is positioned to engage all of these communities not only in student CTE opportunities but adult CTE opportunities as well. Further, the career center was not affected by the flood and was not mentioned in the pre-flood, 10-year Comprehensive Education Facilities Plan (CEFP). The NCCTC is a critical asset for the growth and engagement of several communities.

Conclusion:

The most recent educational research does not support positive outcomes from either the original consolidation plan or the proposed mediation compromise plan. These proposals do not address the pre-flood CEFP critical needs, are not fiscally responsible with taxpayer money, and will lead to decreased support for the general and excess levies. This will have devastating financial consequences on the school system.

Reasonable and Equitable Plans:

Compared to the consolidation and mediation proposals, the following fair and equitable plans adequately provide a thorough and efficient education for all students in the county. They were formulated by engaging the local educators and are based on research and data, community input, FEMA funding options available, and pre-flood and post-flood needs.

Plans 1,3, and 4 have no negative educational or economic impact on any community in the county. All four of these plans would begin the healing process between communities and bolster the chance to maintain future levies.

Plan 1

Utilizing FEMA Standard Procedures Grants

The lion's share of the loss of schools in Nicholas County happened in Richwood. The most fair and equitable plan is to rebuild the three flooded schools by utilizing the FEMA Standard Procedures grants. This comes with no financial risk to the county or the state and makes the schools in Nicholas County whole.

Pros:

- 1) Retain the current configuration that has been proven highly successful.
- 2) It immediately eliminates all inner-county controversy because it puts us back to what has been proven to be an award-winning system and serves every community.
- 3) Better serves the lower socioeconomic students throughout Nicholas County.
- 4) Eliminates the financial risk of the local and state tax payers of any cost overruns on the construction of the new schools including cost estimate and land purchase/development deficiencies.
- 5) Current general operating maintenance funds could be reallocated to take care of deferred maintenance at other community schools.
- 6) Current excess levy funds could be reallocated from capital projects on these schools to improve other community schools.

Cons

- 1) Does not address the facility needs from our current CEFP of which Summersville Elementary is the most critical.
- 2) Does not allow for the needed expansion of the CTE program and facilities.

Plan 2

State Board of Education's Original Plan

This consisted of a 6-12 on each end of the county with CTE at both facilities and was mentioned by Dr. Paine as a possible solution at a State Board meeting in 2017. It could be effective if the schools were of equal size and scope due to the previously mentioned school district student population numbers.

Pros:

1) Creates equal and fair opportunities for all middle and high school students in the county. 2) Would be readily acceptable by the general public as a fair and equitable solution.

- 3) Would enhance the opportunity to heal our educational community by maintaining individual school identities and cultures.
- 4) Would keep intact a healthy competitive rivalry while allowing the community to heal.

Cons:

- 1) This would utilize the FEMA 428 Grants and put a significant risk on the local and state taxpayers.
- 2) To create equal opportunities in CTE programs would require duplication of services which would increase operating costs.
- 3) It would eliminate the possibility of continuing a CTE relationship with neighboring Webster County.
- 4) Does not address the facility needs from our current CEFP of which Summersville Elementary is the most critical.
- 5) Puts at risk and already proven successful model CTE school in WV by changing its configuration and location.
- 6) Does not protect all communities and economically damages Craigsville, the fastest growing communities in the county.
- 7) Would require demolition of one of the most structurally sound facilities in our county built on a parcel that was purchased in order to be large enough for future expansion.

Plan 3

Modified State Board of Education Plan

This consists of a 6-12 on each end of the county while leaving and bolstering the CTE program in Craigsville and was also mentioned by Dr. Paine as a possible solution at a State Board meeting in 2017. It would be effective if the schools were of equal size and scope and promotes additional educational opportunities.

Pros:

- 1) Creates equal and fair opportunities for all middle and high school students in the county. 2) Would be readily acceptable by the general public as a fair and equitable solution.
- 3) Would enhance the opportunity to heal our educational community by maintaining individual school identities and cultures.
- 4) Would keep intact a healthy competitive rivalry while allowing the communities to heal.
- 5) Protects all communities in the county from the negative effects of losing an educational and economic resource.
- 6) Maintains an already proven successful model CTE school in WV by retaining its configuration and location.
- 7) Allows for the expansion of student and adult CTE programs in a centralized location for two counties.

Cons:

1) This would utilize the FEMA 428 Grants and put a significant risk on the local and state taxpayers.

- 2) Does not address the facility needs from our current CEFP of which Summersville Elementary is the most critical.
- 3) Would require demolition of one of the most structurally sound facilities in our county built on a parcel large enough for future expansion.

Plan 4

Common Sense Plan

The replacement of the flooded schools as well as the replacement of Summersville Elementary as a stated need in the current CEFP are addressed using a combination of FEMA Standard Procedures and 428 Alternative Procedures funding. A 6-12 shared campus or facility can be built in Richwood utilizing the FEMA Standard Procedures and Direct Relocation for RHS. This minimizes the financial risk and provides for land purchase and infrastructure for this site. A 6-8 shared campus or facility can be built in Summersville utilizing the FEMA Standard Procedures and Direct Relocation for RMS again minimizing the financial risk and providing funding for land purchase and infrastructure. A 428 Alternative Procedure grant would be utilized on the Summersville Middle School to build a new Summersville Elementary and to expand and enhance the current CTE in Craigsville. Many other land opportunities are available in the immediate vicinity of NCHS that would keep NCHS, SMS, and possibly Summersville Elementary in close enough proximity to share service and professional personnel and reduce operational costs.

Pros:

- 1) Creates equal and fair opportunities for all middle and high school students in the county.
- 2) Would be readily acceptable by the general public as a fair and equitable solution.
- 3) Would enhance the opportunity to heal our educational communities by maintaining individual school identities and cultures.
- 4) Would keep intact a healthy competitive rivalry while allowing the communities to heal.
- 5) Protects all communities in the county from the negative effects of losing an education and economic resource.
- 6) Maintains an already proven successful model CTE school in WV by retaining its configuration and location while also providing capital to bolster the facility and develop additional programs.
- 7) Allows for the expansion of student and adult CTE programs in a centralized location for two counties.
- 8) Addresses the most crucial need from the most current CEFP by building a new Summersville Elementary.
- 9) Minimizes the use of the FEMA 428 Grant which reduces the financial risk associated with the 428 program.
- 10) Preserves the usage of one of the most structurally sound facilities in our county which includes a parcel that was purchased to accommodate future expansion.

Cons:

1) Still partially utilizes the FEMA 428 Grant and puts some financial risk on the local and state taxpayers.

Subject: Nicholas County Board of Education Consolidation Plan

This letter is in support of the Initial Nicholas County Board of Education Plan for consolidating schools in Nicholas County.

As an introduction: I am currently a science teacher at Webster County High School, where I have taught various science classes for about 25 years. I have been a resident of Craigsville, Nicholas County, WV for about 17 years. As a teacher at Cowen High School when the decision to consolidate Cowen and Webster Springs High Schools was made and subsequently accomplished, I have seen firsthand the benefits of consolidation.

In the presentations during the closure meeting at the Nicholas County Career and Technical Center, many of the speakers referenced that they were "speaking from the heart" or "what is the matter with speaking from the heart?." There is nothing wrong with speaking of your heart felt convictions. However, in science, as directed by "State Standards", we teach the Scientific Method. To refresh memories, because everyone, no matter where they studied science, has learned that the steps of the scientific method are designed to prevent bias (speaking from the heart) but rather to think and make decisions (from the head) based on evidence, data and other facts.

Financial Facts:

- 1). In Webster County, the voters had to pass a bond to finance the new consolidated high school, which resulted in increased property taxes for the citizens of Webster County. In Nicholas County, the bulk of the financing will be provided by FEMA and the School Building Authority, if timely decisions are made, thus no tax increases for the citizens of Nicholas County.
- 2). The legal expenses of the Nicholas County Board and any "delay" costs are not eligible for refunds from FEMA (if I understand their policy correctly) thus the taxpayers of Nicholas County will be required to pay for legal costs to defend the Board against the (in my opinion) frivolous lawsuit(s) of some residents.
- 3). If we (the taxpayers of Nicholas County) are deprived of this opportunity, we will be paying for future building projects. As everyone knows, the loss of coal severance taxes and property taxes has resulted in very tight budgets for the County Commission and the Board of Education.

Remember, we are not looking at next year, or the next 5 - 10 years but for the next 30 - 40 years. Webster County High School opened in 1974, about 44 years ago. There has been some remodeling of various areas but the basic building is the same as it was in 1974. Please do not let this opportunity pass us by.

Educational facts:

- 1). At the time of consolidation in Webster County (both schools with approximately 400 students grades 9-12), the science departments of the schools (Webster Springs and Cowen) were limited in the upper level elective classes that could be offered. Usually, physics, advanced biology, chemistry 2, etc. were taught on a rotating (every other year) basis with 8-10 students in a class (not the most efficient use of staff). After consolidation, these classes were offered annually with a full complement of students.
- 2). Prior to consolidation, Webster County did not have a Career Technical Center (Vocational). Following consolidation, the Career Technical Center was available on the same campus as the "academic" wing and therefore students moved from one setting to the other with no "lost" time. Currently in Nicholas County, a bus ride of 20 30 minutes is required for the Career Center students which can result in the loss of class time for other elective subjects.
- 3). Currently, at Webster County High School, approximately 8 10 dual credit (high school and college) courses are offered. These classes are through New River Community and Technical College, Glenville State College, Fairmont State University and Marshall University. Classes include various science, math, English and social studies classes. In addition to the dual credit classes, AP classes are offered in science, English, social studies and math. Many students and parents do not realize the financial savings of students successfully completing dual credit classes. A student at WCHS can graduate with 15 25 College credit hours (essentially a college semester) for which the parents did not have to pay for books, living expenses (other than at home), etc. I do not know how many dual credit and AP courses are currently offered at Nicholas County and Richwood High Schools but have been told not near as many as at WCHS, a consolidated High School.

In Conclusion: I believe that I am speaking for "a silent majority" of Nicholas County residents who do not defame people on social media, do not call those with different opinions names and do not threaten people or their families. I believe students (all students) of Nicholas County deserve the best facility that can be provided. If you are thinking with your head, I believe you will agree that a consolidated facility will provide the best opportunities for all our students for many years to come.

In My Opinion: FEMA, Fairness and Safety for Students with Two High Schools, How Big or Small and Where? What Is FAIR and SAFE for Students?

To answer that question we should, in my opinion, consider the following:

1.) What is an agency's mission and how does that affect how they do things? In working with any government agency it is important to ask good questions. Understanding an agency's policies and meanings behind certain terms, is also important; if one wishes to avoid a severe case of whiplash. Sometimes messages are indirect, for example: If a county moves a school after flood damage, FEMA might pay for a new school. If the county moves the new school far enough from flood danger that new ball fields are needed, FEMA will often pay for a new school and new ball fields. Why does FEMA do that? Part of the mission of FEMA is to get people and their things out of harm's way. Using incentives is a polite way of overcoming people's resistance to change.

How strong is FEMA's commitment to safety? After a 1993 flood, FEMA agreed to pay for moving an entire town (Valmeyer, Illinois) to much higher land. After the 1985 flood, Marlinton moved its hospital and schools several miles, so each could be high on a hill and away from Greenbrier River. In a similar way, Nicholas County would receive millions more in funds for moving a high school and its ball fields to much higher land. Meanwhile even the Nicholas County Sheltered Workshop is eligible to receive \$1,000,000 from another federal agency, because a large part of Nicholas County flooded in 2016. So FEMA isn't the only federal agency that has incentives for moving things out of harm's way. (Federal dollars are often prioritized for counties with recent flood damage to help them recover, but given to entities that are not in the flood area.)

2.) What do you see as important risk and time issues? What would you dismiss as unimportant?

Richwood had major flooding in 1932, 1937, 1954, 1969, 2003 and 2016. So many people in Craigsville, Calvin, Cottle, Leivasy, Nettie and Tioga don't want their children anywhere near the Cherry River during bad weather. Why should these people take a risk, when it's safer and closer for their children to get to either Nicholas County High School (NCHS) or the 50 to 175 acres in Glade Creek Industrial Park?

This has been a source of considerable misunderstanding, so some discussion is needed. Some people will say: "In my car I can get to... faster than..." What they need to think about is how the buses have to travel. Often there are too few high school students to run a separate bus. For Leivasy and Nettie, buses go to Panther Creek Elementary School (PCE). From PCE it is closer to NCHS. But old district lines cause 54 students to make a long trip to Richwood High School (RHS), currently located at the old Beaver Grade School. Why not change these students to NCHS, so they can be in real classrooms rather than classroom pods? Putting them on a shorter bus ride would allow the buses for PCE elementary students to start later. For Craigsville, Calvin, Cottle and Tioga, going to RHS at Beaver is the shortest bus ride. After the years of pod classrooms are over; then what? All are closer to Glade Creek site than to proposed sites in Richwood. One may well argue that students on Crupperneck Road and Schindel Road are closer to Richwood. However, the elementary school buses that pick up

these students go to Gauley River Elementary School. This provides enough students for a high school bus, but this location is closer to Glade Creek than Richwood.

If all these students get what's fair to them and thus go to Glade Creek, there might be 100 students left for RHS. IF plans for Glade Creek are approved, the Vo-Tec at Craigsville will be available. It has four small classrooms and five larger classrooms, plus 2 shop rooms (2,000 sq. ft. and 4,000 sq. ft.).

This building could serve as a temporary home for RHS, and thus give Richwood more time to repair its water lines, sewer lines and sewage treatment plant. FEMA turned down Richwood's request for millions needed for repairs. Is part of this denial due to the location of the sewer lines, sewer plant and water lines? If so, will FEMA pay far less for a school that is close to the Cherry River? Why take that risk?

- 3.) Which numbers are most important to you?
- 1,050 students live closer to Glade Creek. About 100 live closer to Richwood. Of that total of 1,150, about 300 live closer to Craigsville. By this measure Craigsville has a better argument for a high school than Richwood, but Governor Justice, reportedly, wants a high school in Richwood. Using Vo-Tec as a temporary home for RHS may be the only way Governor Justice can get what he wants, until other issues are resolved.
- 4.) How important are roads in this discussion?

From one point of view, Richwood is essentially landlocked. Until Greenbrier Road and other roads are widened to permit safer passage of buses and trucks, economic development opportunities will be lost. Will Governor Justice's road program include fixing these roads? If not, why not?

5.) Are some people in denial of the potential for flooding and rock slides? Are they being heard over those who are concerned about the potential of flooding and rock slides for cutting off access to students?
