RE: WV Universal Pre-K Program Review Triennial Schedule (2018-2021)

The West Virginia Universal Pre-K Steering Team is pleased to announce the Pre-K Program Review Triennial Schedule for school years 2018-2019 through 2020-2021. The WV Universal Pre-K Program Review process is a key requirement of WVBE Policy 2525: West Virginia's Universal Access to a Quality Early Education. As a result, the West Virginia Department of Education, in collaboration with the West Virginia Department of Health and Human Services, and the Head Start State Collaboration Office, are required to conduct a WV Universal Pre-K Program Review in each county a minimum of once every three years. The WV Universal Pre-K Program Review process serves to support county collaborative early childhood teams in implementation of WVBE Policy 2525. The review process is also designed to provide ongoing individualized technical assistance to support each county's continuous quality improvement process.

In addition to the triennial schedule, the Pre-K Program Review schedule for the 2018-2019 school years has been established. A separate memorandum will be provided to those counties scheduled for review during the upcoming school year. It includes review dates and specific guidance on the review process.


