### MINUTES WEST VIRGINIA BOARD OF EDUCATION Capitol Building 6, Room 353 1900 Kanawha Boulevard, East Charleston, West Virginia March 10, 2021

#### **Call to Order**

Following the welcome and Pledge of Allegiance, President Miller L. Hall called the meeting of the West Virginia Board of Education (WVBE) to order at 10:00 a.m. on March 10, 2021, in Capitol Building 6, Room 353, 1900 Kanawha Boulevard, East, Charleston, West Virginia.

Clayton Burch, State Superintendent of Schools, and Sarah Armstrong Tucker, Chancellor, West Virginia Higher Education Policy Commission and West Virginia Council for Community and Technical College Education. Member absent was Thomas W. Campbell.

#### **Approval of Agenda**

President Hall called for a motion to approve the agenda. Mr. Rotruck moved, and Mrs. Sullivan seconded, that the agenda be approved. Upon the call for the question, the motion was carried unanimously.

Mr. David Gladkosky, Executive Director, West Virginia Professional Educators, addressed the Board regarding teacher comments pertaining to in-person learning and legislative bills affecting education. Dr. Mickey Blackwell, Executive Director, West Virginia Association of Elementary and Middle School Principals, requested members visit a school as often as possible and speak with principals and teachers. Mr. Fred Albert, President, American Federation of Teachers-West Virginia, and Mr. Dale Lee, President, West Virginia Education Association, addressed the Board regarding legislative bills affecting the future of education.

#### IV. West Virginia Higher Education Policy Commission/ West Virginia Department of Educator Preparation Taskforce

Chancellor Tucker addressed the Board regarding the Promise Scholarship and efforts to assure that all eligible students make application, completion of the Free Application for Federal Student Aid (FAFSA), and grant availability.

Dr. Carla Warren, Director, WVDE Educator Development and Support Services, and Dr. Corley Dennison, Vice Chancellor for Academic Affairs, West Virginia Higher Education Policy Commission, provided an overview of the work of the Educator Preparation Taskforce. Dr. Jan Barth, Assistant State Superintendent, provided information regarding a national survey she

### XI. Education Bills of the 1<sup>st</sup> Session of the 85<sup>th</sup> Legislature of West Virginia

Ms. Sarah Stewart, Government Affairs Counsel, WVDE Office of Legal Services, provided an update of legislative education bills. Ms. Heather Hutchens, General Counsel, WVDE Office of Legal Services, provided an update regarding House Joint Resolution One (HJR1), 2021 Regular Session, a proposed amendment to the Constitution of West Virginia, that would impact the WVBE's rule-making authority. Discussion ensued regarding HJR1. Superintendent Burch requested the Board join him in issuing a public position statement regarding HJR1 and that the Board take a formal stance on HJR1.

Following discussion, Dr. Maynard moved that the WVBE stand opposed to HJR 1 and direct the State Superintendent to prepare a statement summarizing its objections. Mrs. Sullivan seconded the motion and upon the call for the question, the motion was carried unanimously.

### XII. Role of the School Counselor During Coronavirus Disease (COVID)

Ms. Stephanie Hayes, Coordinator, WVDE Student Support and Well-being Services, and Mr. Derek Lambert, Coordinator, WVDE Middle and Secondary Learning Services, provided information regarding the role of the school counselor during COVID. (PowerPoint appended to Official Minutes, Attachment P.)

Superintendent Burch thanked Mr. Adam Cheeseman, Superintendent, and Mr. Denver L. Burnside, President, Doddridge County Board of Education, for making his visit productive and memorable. Superintendent Burch, assisted by Ms. Hayes, provided an overview of the West Virginia Snapshot: Student Support and Well-being website; assisted by Ms. Melanie Purkey (distributed information), Senior Officer, WVDE Office of Federal Programs and Support, provided information regarding West Virginia's federal accountability and assessment waiver to be released today for public comment for two weeks; Ms. Sonya White (distributed information), Teaching and Learning Officer, WVDE Office of Teaching and Learning, provided information regarding Summer Opportunities for Learning and Engagement (SOLE); Superintendent Burch announced that Governor Justice has made funding available to add nine counties and 37 schools to the Communities In Schools initiative for a total of 32 counties and 153 schools participating in the initiative; assisted by Ms. Christy Day, Director, WVDE Communications, presented a timeline of WVDE COVID actions; and, Superintendent Burch provided an overview of the charge and expectations of the West Virginia Superintendent's Education Advisory Team and provided an update regarding four-day in-person instruction waivers.
