

## **Common Ground Compact Addendum Document**

**1. Purpose.** This addendum is to be used for the purpose of allowing new partners to be added to the Common Ground Partnership, its activities and its Compact. The most up-to-date Compact became effective on December 7, 2021.

**2. Scope.** The organizations included in this addendum agree to contribute to the scope found within the Common Ground Partnership's most recently approved Compact document, which became effective on December 7, 2021.

The Compact and this addendum are non-binding, but intended to establish expectations for cooperation among all compact parties as per the previously signed document's agreements and the agreements of this document identified below:

**L. Army ROTC-West Virginia Task Force Miner will:**

- Provide one primary point of contact representing the entire Task Force to support the mission and efforts of the Common Ground Partnership
- Actively participate in meetings of the Common Ground Partnership, sharing information and exploring ways to contribute to its activities
- Participate in the Common Ground Partnership's Speaker Series, providing soldiers for guest visits to schools
- Provide support to JROTC and other programs in schools to ensure success for ALL students
- Provide mentors as appropriate to inspire students to stay in school and graduate
- Provide professional development and technical assistance to principals, school counselors, and teachers
- Provide schools with information about resources, career exploration, benefits and incentives of the military
- Inform educators of opportunities for students to serve as leaders in their communities
- Coordinate visits with school districts and schools for related activities and events

**3. Termination.** Any party hereto may terminate their participation in this Compact upon 30 days notice to the other parties.

**4. Participation.** The Common Ground Partnership's Compact in no way obligates the United States Government or the West Virginia Government to any financial or contractual obligations.

**5. Effective Date.** This addendum will become a part of the previously approved document and effective when the following two measures are met:

- Records are collected by the WVDE showing that a quorum of Common Ground Partners approve of having the entities as described above become part of the Common Ground Compact as verified by a representative's signature.

- All authorized official's signatures from organizations becoming new Common Ground Partners are acquired.
