COUNTY APPROVAL STATUS AND ACCREDITATION

To ensure each county board of education provides a thorough and efficient education for its students, the West Virginia Board of Education (WVBE) shall annually review county scorecards and efficiency profiles provided by the Office of Support & Accountability. County status will be reviewed and determined based on multiple measures of student performance and county operational efficiency.

The WVBE will review annually the information submitted by the West Virginia Department of Education (WVDE) and issue each county board of education an approval status. *W. Va. §18-2E-5 (l) School system approval* – The state board annually shall review the information submitted for each school system from the system of education performance measures and issue to each county board an approval status in compliance with federal law and established by state board rule.

As part of the West Virginia Accountability System (WVAS) outlined in WVBE Policy 2322: *West Virginia System of Support and Accountability*, county status will be reviewed annually to determine two accountability measures:

- **County Operational Effectiveness Indicators of Efficiency** – Counties will receive a rating of *Meets Requirements* or *Needs Assistance* on each of the 11 efficiency indicators. A rating of *Needs Assistance* indicates the county, with assistance from the WVDE, must develop an action plan and monitor the plan’s implementation towards showing improvement. Further support or corrective actions by the West Virginia Board of Education may be taken based on the county’s acceptable progress or lack of progress on the indicator(s).
- **West Virginia Balanced Scorecard Indicators of Student Performance and Success** – County-level Balanced Scorecard indicator(s) that receive *Does Not Meet Standard* will result in the county being designated as *On Watch* for the indicator(s). A rating of *On Watch* means it is the county’s responsibility to monitor for continuous growth and improvement of its students. The following year’s Balanced Scorecard data will be used to determine if student growth and improvement did or did not occur.

Note: Lincoln County Schools is currently under a State of Emergency as outlined in W. Va. Code §18-2E-5(m)(2). The WVDE is actively working with Lincoln County Schools to correct all noncompliance and findings outlined in the Special Circumstance Reviews conducted by the Office of Accountability. Lincoln County Schools will receive approval status as a result of continued progress on correcting deficient areas of operation.

Note: Upon receipt of the Special Circumstance Review report presented October 27, 2022, the WVBE voted to immediately intervene in the operation of Logan County Schools as per W. Va. Code §18-2E-5 and has therefore issued Logan County Schools a non-approval status until acceptable progress is demonstrated.

Counties Receiving “On-Watch” Identification for West Virginia Accountability System Indicators
