2024 West Virginia Assessment Results

The 2024 state summative assessment results consist of combined student performance across all the state's summative assessments, including the West Virginia General Summative Assessment (WVGSAs) in grades 3-8, the SAT School Day in grade 11, and the West Virginia Alternate Summative Assessment (WVASAs) in grades 3-8 and 11. Results are based on the performance of students who are enrolled for a full academic year, meaning they were enrolled for at least 135 days during the school year and were present in the end-of-year enrollment file.

The 2024 assessment results provide valuable information as the West Virginia Department of Education addresses student learning and ongoing improvement in student achievement.

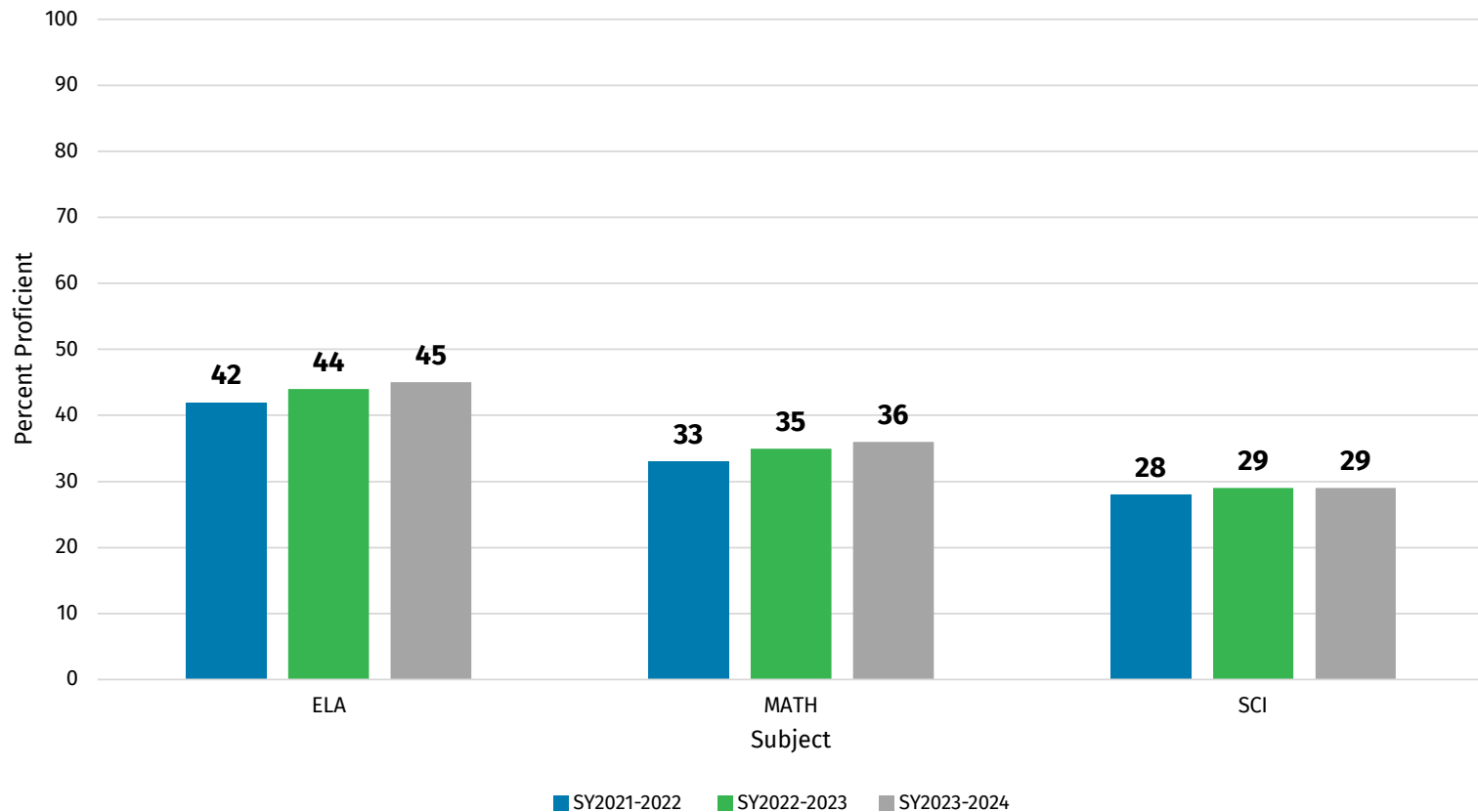
Important Points to Consider

- » West Virginia successfully administered statewide assessments to more than 95% of students in Grades 3-8 and 11.
- » In spring 2024, West Virginia moved from a fixed-form paper-pencil administration of the SAT School Day in grade 11 to the new staged-adaptive digital SAT School Day, which shortened testing time from about four hours to just slightly more than two hours.
- » Results are shown for 2022, 2023, and 2024.

West Virginia Statewide Summative Assessment Results

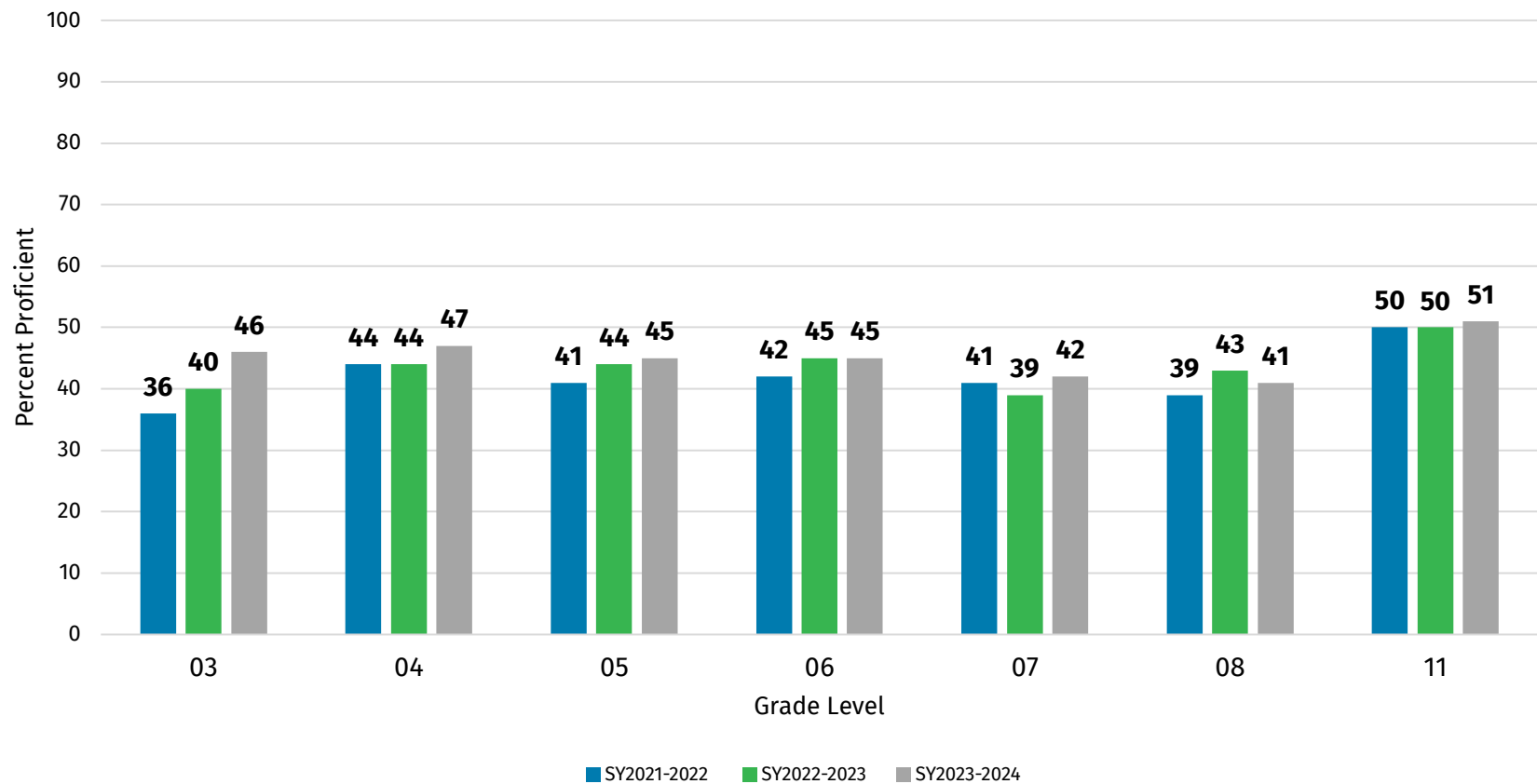
Overall Percent Proficient

2022, 2023, 2024



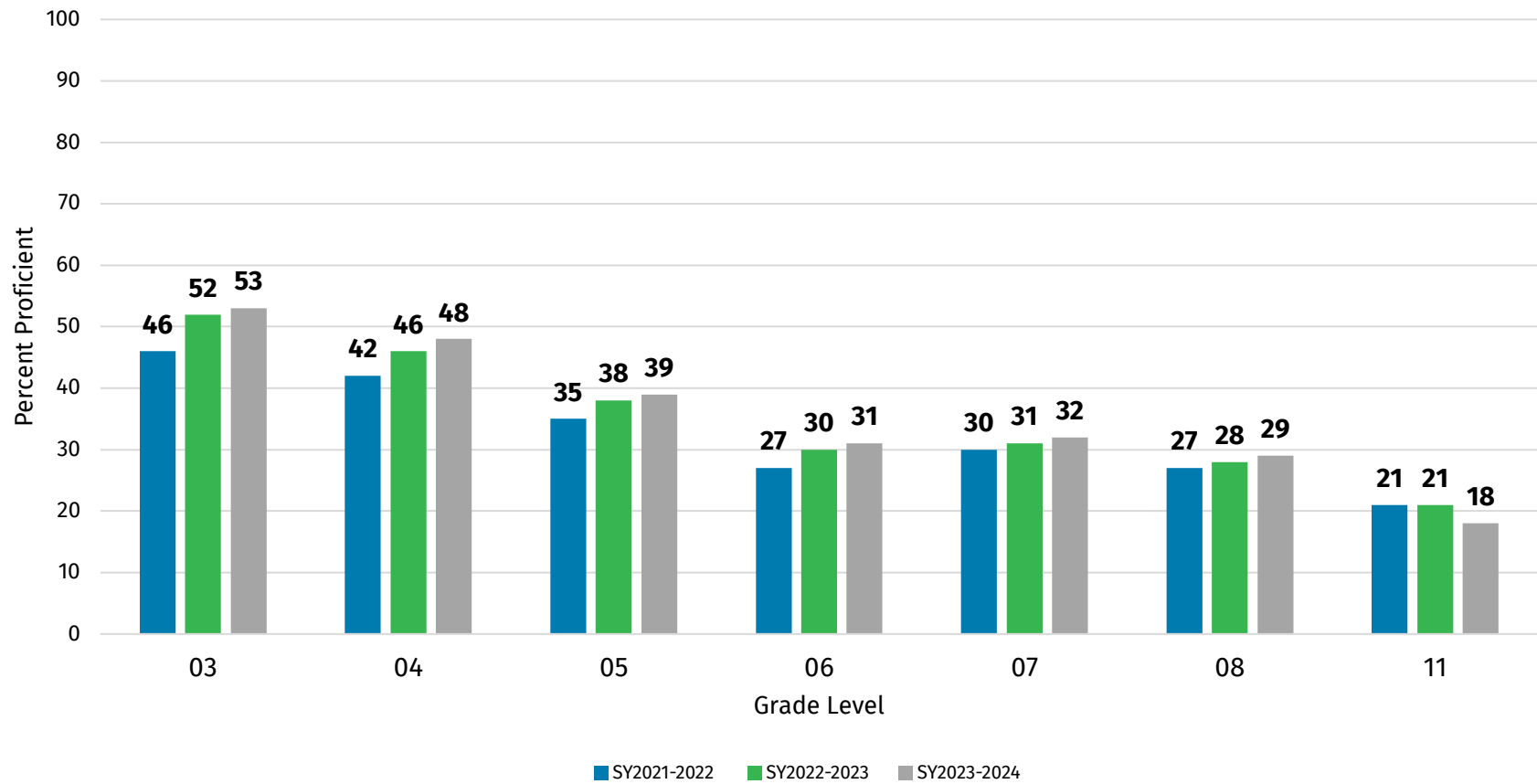
English Language Arts Percent Proficient

2022, 2023, 2024



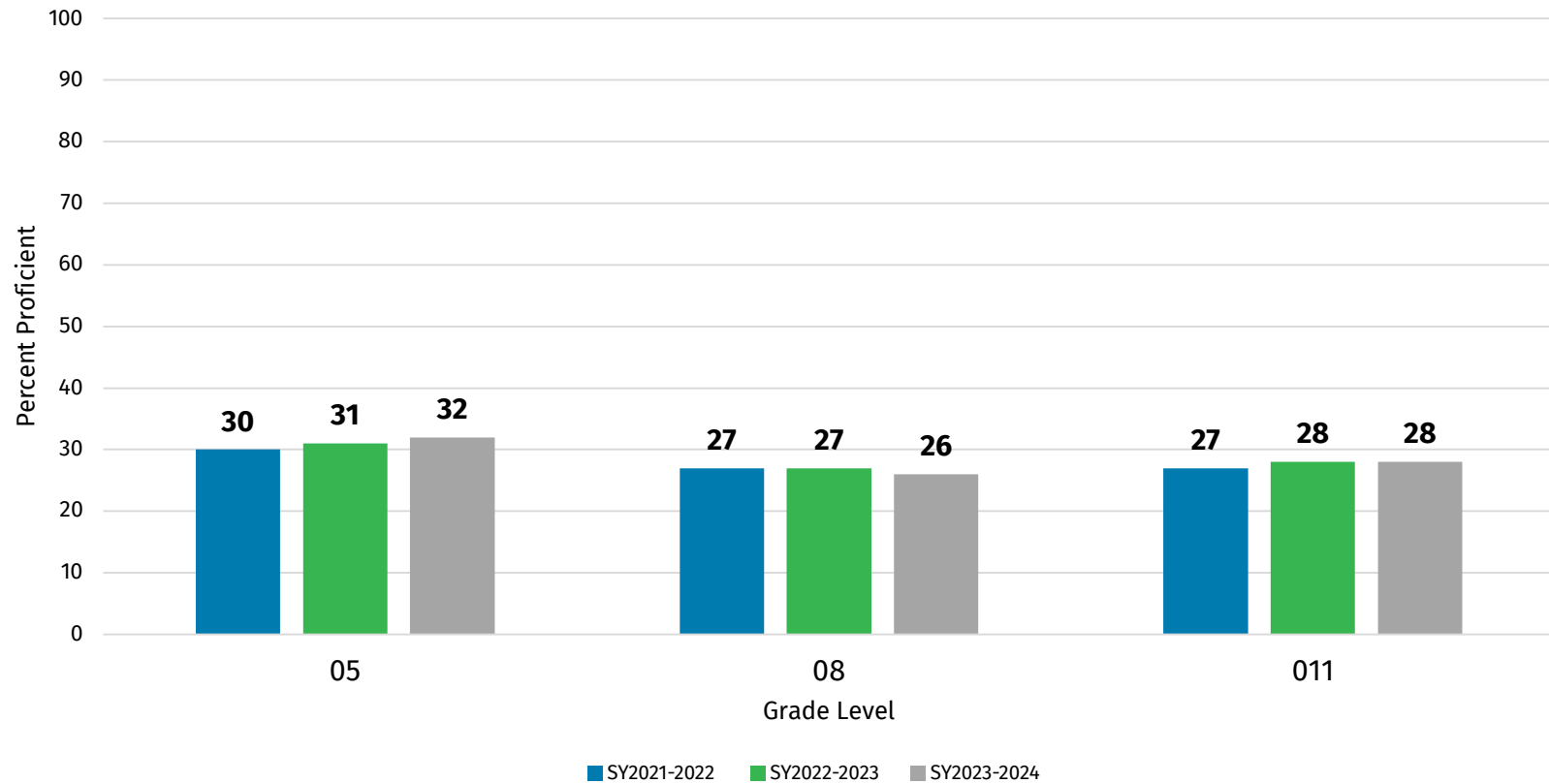
Mathematics Percent Proficient

Frequently Asked Questions About West Virginia's 2024 Statewide Assessments

Why are students required to take statewide assessments?

- » West Virginia is required by federal and state law to administer annual statewide assessments. West Virginia's statewide assessments – which include the West Virginia General Summative Assessment in grades 3-8, the SAT School Day in grade 11, and the West Virginia Alternate Summative Assessment in grades 3-8 and 11 – provide critical information about individual student performance and about where West Virginia needs to better support students, teachers, and schools across our state. Our goal is to use the results to create a stronger and more equitable education system.

What was the state's student participation in statewide assessments in spring 2024?

- » Participation in statewide assessments in 2024 in grades 3-8 and grade 11 was above the 95 percent required by the federal government. Assessment participation, however, may have varied across counties and schools.

How will the state, district and school leaders, and educators use the assessment results?

- » Assessment results are just one of several strategies used to evaluate student achievement and create a stronger education system. Counties and schools in West Virginia use the information gained from the assessment to strive for continuous improvement and to continue to address student achievement.

How should parents/guardians use the assessment results to support their children?

- » The summative test score is one of many measures used to identify achievement gaps. We encourage parents and guardians to consider their child's results within the context of their learning environment.

How can parents/guardians see their child's assessment results?

- » Schools will provide parents/guardians with information regarding their students' test scores.
