The majority of public schools and several private schools in West Virginia belong to the West Virginia Secondary School Activities Commission. Each year, the principals of member schools submit revisions to the rules and regulations. The submitted proposals are presented and voted upon at the annual Board of Control meeting. Any approved changes are then submitted to the West Virginia State Board of Education for its review and approval. The following proposals dealing solely with classification were presented at a special meeting of the Board of Control on October 24, 2024. The special meeting was held based on a decision rendered by the Review Board in August 2024.

It is recommended that WVSSAC Series 3 be placed on public comment for 30 days from filing.

A. Amendment of Kanawha County's 2020-2030 Comprehensive Educational Facilities Plan (CEFP) - (Action)

Policy 6200 requires all local boards of education to submit amendments to CEFPs to the WVBE and the School Building Authority of West Virginia (SBA) for approval. The Kanawha County Board of Education requests approval to revise their 2020-2030 CEFP to include a change in their project priority list and additional mergers and consolidations. It is being proposed as a top priority that Belle Elementary School, Malden Elementary School, Mary Ingles Elementary School, and Midland Trail Elementary School be consolidated into a new Eastern Kanawha Elementary Center, pending a successful grant application to the SBA. The amendment also includes the closure and merger of McKinley Middle School into Hayes Middle School and the closure and merger of East Bank Middle into Dupont Middle. The middle school closures are proposed to occur at the end of the 2024-2025 school year.

Changes in a county's CEFP are for planning only, and any proposed closures are pending the completion and approval of the official closure procedures established in Policy 6204, School Closings or Consolidations.

It is recommended that Kanawha County Board of Education's request to amend their 2020-2030 CEFP be approved.

B. Kanawha County Board of Education: Closure of Belle Elementary School, Mary Ingles Elementary School, Malden Elementary School, and Midland Trail Elementary School- (Action)

The Kanawha County Board of Education respectfully requests approval for the closure of Belle Elementary School, Mary Ingles Elementary School, Malden Elementary School, and Midland Trail Elementary School and their consolidation into a proposed new Eastern Kanawha County Elementary Center. This closure is contingent upon receiving funds from the SBA and the completion of a new elementary school in the eastern end of Kanawha County. The consolidation of these schools will enable Kanawha County Schools to operate county schools more efficiently.

In consideration of this closure, applicable WVBE policies were reviewed and followed. Documents were available for public inspection for the required amount of time, and closure hearings were held for Belle Elementary School on October 15, 2024; Mary Ingles Elementary School on October 17, 2024; Malden Elementary School on October 21, 2024; and Midland Trail Elementary School on October 22, 2024. The Kanawha County Board of Education voted to approve these closures at the conclusion of each respective hearing.

Based on the information provided, it is recommended that the closure and consolidation of Belle Elementary School, Mary Ingles Elementary School, Malden Elementary School, and Midland Trail Elementary School be approved.

C. Kanawha County Board of Education: Closure of East Bank Middle Attachment P School - (Action)

The Kanawha County Board of Education respectfully requests approval for the closure of East Bank Middle School and its merger into DuPont Middle School. This closure is not contingent upon any other actions and is proposed to occur at the end of the 2024-2025 school year.

Regarding this closure, applicable WVBE policies were reviewed and followed. Documents were available for public inspection for the required time, and a closure hearing was held for East Bank Middle School on October 8, 2024. A receiving hearing for DuPont Middle School was also held on October 8, 2024. The Kanawha County Board of Education voted to approve this closure and consolidation at the conclusion of the October 8, 2024, hearings.

Based on the information provided, it is recommended that the closure of East Bank Middle School and its merger into DuPont Middle School be approved.

Kanawha County Board of Education: Closure of McKinley Middle Attachment Q School – (Action)

A school environment review of Martinsburg North Middle School was conducted on April 17, 2024, at the request of the WVDE Office of District and School Improvement. The review was presented to the WVBE in May after which the WVBE declared a State of Emergency existed at Martinsburg North Middle School and directed that an action plan, in collaboration with the WVDE Division of District and School Accountability and Berkeley County Schools leadership, be developed and presented to the WVBE for action. The WVBE approved the action plan on June 12, 2024.
